

FAQS For Financial Markets Management

Q1. What is the scope of FMM?

A. The scope of FMM is in Banking, Insurance, Stock Markets, and Brokerage houses. In these sectors skilled people are very few as compared to the jobs available.

Q2. Is this subject related to marketing?

A. No, this subject is totally different from marketing. It is about financial markets like stock markets and not sales & marketing.

Q3. Financial market management. "Which market are we learning about "?

A. In this course we are going to study about different financial markets like stock market, capital markets and money markets.

Q4. What is the main purpose of introducing these vocational subjects?

A. The main purpose of introducing these vocational subjects is to train students and make them employable in a specific skill.

Q5. Will there be certification of all the levels completed?

A. Yes you will get certificates for each level after successful completion.

Q6. What will be advantage of completing all levels, Level 1 to Level4?

A. You will acquire skills. You will get certificates for all the levels and finally you will be job ready. You will also get assistance for placement in companies.

Q7. What are the places students will visit as part of field visits?

A. Banks, Brokerage houses, and Stock Exchanges

Q8. Are we getting any practical training for this?

A. Yes, at each level you are getting a different module of practical training

Q9. What if I complete only level 1 & 2 and discontinue thereafter.

A. Knowledge, skills and certificates earned till level 2 will be given a weightage.

Q10. Where do we get practical training, in the school or elsewhere?

A. Practical training will be in your own school. The school's computer lab will be used for this purpose.

Q11. Will I get computer knowledge?

A. Yes you will be given a training on NLT software which will start with basic computer knowledge.

Q12. Can a student change Vocational Subject in class X or later?

A. No. Class IX is Level 1 of the Vocational subject. Class X is Level 2. Unless the student clears Level 1 s/he may not be allowed to take Level 2.

Q13. What about books? Will they be available in Hindi? What will be cost of Books?

A. Yes, books are available in Hindi & English. Cost is around Rs200/=.

Q14. What option is available if I change school due to stream (Science/ Commerce etc. not available in present school)?

A. If the new school has the vocational subject FMM you can continue to pursue it in the new school.

Q15. Whether I will be employable after Level 2 or class 10?

A. To be employed you need to be 18 years old which is the minimum age. Your Level 2 certification will be given weightage for employment.

Q16. Will I will be provided any job opportunity? If yes, after which class or Level?

A. We will provide placement opportunities after Class 12 for Level 4 candidates.

Q17. What are the other value additions to be provided during course? If yes, is there any cost I have to bear during any level?

A. The course is being conducted by experienced faculty. You will have guest lectures and Industry visits too. You will have practical training in the school. You do not have to pay anything extra for these.

Q19. Whether marks in vocational subject has any impact on CGPA or it is just optional. If not, why should I go for it?

A. In IXth and Xth vocational subjects are optional. In XIth and XIIth it is proposed to make it compulsory.

Q20. Is it compulsory to join? In my friend's school, he/she was not forced to join vocational course last year?

A. It is not compulsory to join. But this is a great opportunity you are getting without paying more. If you do this course privately you will have to spend Rs 30000 to Rs 60000.

Q21. What kind of knowledge will be imparted in guest lectures?

A. Knowledge related to finance and your course of study. You will gain insights on the career options for you.

Q22. What teaching methodologies are used in teaching FMM?

A. It will be a blend of classroom lectures, video lectures, seminars, industrial visits etc.

Q23. Where I will be employed after completing level 4?

A. Banks, insurance companies, brokerage houses, stock exchanges, financial institutions etc.

Q24. If I start working directly after level 4 or class 12th, how will I be able to do my graduation?

A. You can always complete it through correspondence mode. The option is yours. Work and study or study, complete your graduation and work. The course will also help you in your graduate studies.

Q25. Who has designed the FMM course?

A. CBSE and NSE together have designed the course.

Q26. Is vocational subject an additional burden on students?

A. No, it will not be a burden because 60 percent marks are for practical which students will enjoy if they attend regularly.

Q27. Will introducing these subjects in 9th class help the students in higher class?

A. Yes. These subjects are basic and important for students pursuing commerce or accountancy.

Q28. If students fail in class 9 and cleared in this subject so are they permitted to go in level 2.

A. No for this they have to clear class 9 and once they are promoted to class 10 then they will go for level 2. However, they will get a certificate in Level 1 and do not have to repeat the course.

Q29. Will the students of CBSE with FMM certification get preference for admission to BBA (FMM)?

A. Students with FMM certification will be given preference for admission to BBA (FMM).

Q30. Is it a good career option for girls?

A. Yes, it is an excellent choice. You have options to work from home too.
